- 11. Special Projects: Stacey Hill (93), Chair of committee. Co-chair is Maureen Jones. Committee has 7 members. Purpose of committee is to support the college by identifying special projects needed on the campus and notifying the RCIAA Executive Board. Two projects completed since July 2020: RCIAA sponsored and provided 3,000 masks from Cummins Company, Memphis, TN and per the call of duty from President Taylor, the RCIAA has provided 103 students supplies and other necessities hat were affected by covid-19 and quarantined at the college. \$500 was spent on the supplies. Upcoming project is the Adopt a Student Project. Alumni VOTE: Elections Committee Chair, Sabrina Rawls discussed the procedures for voting electronically.

By-Laws Revision Update: Committee Chair, Brian L. White reported the major changes to the Bylaws, these include a New Executive Position – Treasurer, include the Parlimentarian as the chair of the Bylaws committee, electronic processes and how the RCIAA should handle special elections.

Question: Dennis Harrell stated the Secretary did not read and the RCIAA did not approve the previous meeting minutes. Mr. Harrell stated that the RCIAA did not have the authority to revise the constitution and bylaws without the vote of the body. Mr. Harrell stated that the RCIAA was out of order, due to the fact that there were no previous meeting

Response: President Belfoure stated that there were no minutes and there has never been any minutes from the RCIAA annual meeting in the past 10 years. The RCIAA cannot go back in the past but can move forward the correct way by implementing procedures so that the RCIAA can operate in order. No comments were made regarding the minutes from the Office of Alumni Affairs or past RCIAA President Larry Anderson. Past Secretary Gail James stated that she was not in office at the last meeting but would follow up with the Office of Alumni Affairs regarding the minutes.

Motion: Dennis Harrell moved that the voting of the bylaws be tabled until the next meeting or Special meeting due to the fact that there are no minutes showing the body voted to have the bylaws amended. Joel Harrell seconded the motion. Parlimentarian Damien Jackson Ellington clarified that the Bylaws did not states the RCIAA cannot vote on amendments to the Bylaws without the previous meeting minutes.

Questions/comments for the Motion: 1). Joel Harrell clarified that the issue is <u>not</u> the absence of the previous RCIAA annual meeting minutes; but, the fact that the body did not vote to have the Bylaws reviewed and amended. Also, the 30 day notification requirement included in the Bylaws had not been met. Mr. J. Harrell stated the RCIAA was violating the current Bylaws by taking actions today. Further, the Bylaws do not address the MI relationship with the Association. J. Harrell stated 30 days will give us time to allow the alumni to comment on the Bylaws. 2). Another alumni commented that there were five amendments in the revised Bylaws that needed to be voted upon separately and not all inclusive of the Bylaws. 3). Point of Clarification: Judge Paula Drungole Ellis stated that the alumni didn't understand clearly the vote. President Belfoure Redditt clarified that the RCIAA want to give all alumni the opportunity to review the Bylaws and allow for edits/changes to be made before voting. Parlimentarian Damien Jackson Ellington clarified per the RCIAA Bylaws the authority to make changes to the bylaws and allow 30 days for the alumni to vote on the amendments. Paula Drungole Ellis stated the bylaws committee needed a legal representation on the committee due to the wording in the bylaws. It was suggested that a legal representative assist with the wording of the constitution and bylaws.

Joel Harrell stated The Zoom feature "raise of hand" was not an effective way to vote; therefore the technology committee created a poll and the vote was held electronically. The vote passed to table the bylaws until the next alumni meeting or a special meeting was held to vote on the bylaws after allowing the financial member 30 days' notice and to provide comments/suggestions/edits to the proposed amendments.

Alumni Gail James, asked a question asked about the newsletter (PAWS Report). President Belfoure Redditt commented that all financial alumni should have received a Blue Bearcat Founders Day Envelope that was mailed from the Office of Alumni Affairs. Some alumni expressed concerns that the Blue Bearcat Envelopes had not been received. The PAWS Report is the alumni association Newsletter, launched in November.

Vote Session was interrupted to allow Dr. Ivy Taylor, President of Rust College to address the assembled body.

Update of the College Address (Dr. Taylor)

- a. Students are not in a 100% virtual instruction and 2 weeks quarantine. Between Oct. 20 Oct. 30 the school went from zero student Covid cases to 20 students, topped out at 34 students and 4 faculty members. 320 were on campus; 103 of the students opted to remain on the campus, others quarantined at home or elsewhere. Those that left campus must provide a negative test before returning to the campus. Thanks to the RCIAA responding to the call for assistance for care packages that included snacks and toiletries while quarantined. Meals are being delivered to the students. Return to campus date is November 11, 2020.
- b. Enrollment: 2nd Module 635 total student (320 on campus and others are studying remotely); laptops were given to student to facilitate virtual learning.
- c. Calendar looks different this year: Students will vacate the campus on November 25th for the holidays and will return 3rd Module in January
- d. Plans for in person graduation 2021, it will be an outdoors ceremony. No details as of yet.
- e. Academic experience: Rust is working on several partnerships to enhance the curriculum. The University of Incarnate Word will provide preferred application review for any students interested in attending UIW's School of Pharmacy, Optometry, Physical Therapy and Osteopathic Medicine. Rust recently signed a 3 plus 3 agreement with the Cleveland State University Marshall School of Law, students will attend Rust for 3 years then matriculate at the Law School for the additional 3 years. At the end of the first year at the Law School, the student will receive a degree from Rust. Student will finish a JD in 6 years instead of in 7 years. Another partnership is with University of MS (Ole Miss), a 3 plus 2 Engineering program. Curriculum mapping is being conducted now. Under the leadership of Dr. Doris Ward, Interim VP of Academic Affairs, there is new energy related to academics.
- f. Concerns Related to the Lack of Investment on the Physical Campus. As of Nov. 6, 2020 the Board of Trustee has approved for the college to move forward with Capital Improvement projects. One project includes the campus of MI College dormitories, currently used as the ICS headquarters. These will be suite style dormitories, which will include 4 bedrooms, a living room, and self-contained bathrooms. Improvement projects will include upgrading the bathrooms in Wiff Hall, more user friendly- dressing area near shower. Other change will be to relocate the Gift shop to the Mass Comm building and landscaping. Dr. Taylor will be asking the RCIAA for assistance with fundraising. The costs are projected to be approximately \$3 Million and Dr. Taylor committed to the Board of Trustee that through fundraising the school will be able to assist with at least half of the cost (\$1.5 Million). Longer term plan, strategic plan and a comprehensive assessment of the current physical plant. Rust is beginning an assessment of all the buildings and strategic plans which will involve a number of stakeholders: students, alumni, board, community, etc. By Nov. 2021, a plan will prioritize the additional major improvements at the campus and help to start a capital campaign that is anticipated to be extensive.
- g. Enrollment needs to be stabilized. Enrollment has been on the slide for about 3 years; last fall 737 student; this fall there are 635 students, largely due to COVID; but there has also been no investment or training of the staff in admission of the past years. Rust is working on its marketing, digital footprint, the school desires a stronger relationship with Holly Spring/Marshall County. Improvement is needed with transfer enrollees. Alumni need to help the school and serve as the pipeline, for traditional students. Robust outcome related to enrollment to help stabilize operations, which allows for further investments in software, employees training, so the experience for students, etc. Dr. Taylor stated that she is aware that there is a need for improvements in the alumni office, stay patient. Dr. Taylor would like to work close with the alumni with raising money for the improvement and creating robust enrollment pipelines. Dr. Taylor looks forward to seeing everyone in person.
 - a. Alumni AC Smith asked if the information presented could be provided. Dr. Taylor will forward Board of Trustees report to President Belfoure for dissemination to the alumni.
 - b. Alumni LeRoy Frazier commented Dr. Taylor for her service. Additional comments regarding the staffing changing was asked. Dr. Taylor provided a report of all the staff changes. Hired Dartrell Treadwell and Tiffany Perry.

Vote Session was resumed......

Bylaws resumed: The motion to delay the bylaws until the next alumni meeting or Special Meeting to allow the alumni 30 days' notice. The vote was passed with 96% of the vote.

Motion to review and revise the 1971 Bylaws: Vanessa Chandler moved that the RCIAA review and revise the bylaws. Michael Armstead seconded the motion. The vote passed with 95% yes; 5% no.

Annual 2020-2021 Proposed Budget was presented. Voting of the Budget will take place at the Special call meeting. The proposed budget is attached for review.

Motion for the Special Meeting beyond 30 days: Vanessa Chandler moved that the RCIAA have a Special Alumni Call Meeting beyond 30 days. Yolanda Thomas seconded the motion. The vote passed with 100% yes. 30 days will be December 7th. President Belfoure stated that the date could be December 14th, 2020.

Policies and Procedures will be presented at the Special Alumni Call meeting to be voted upon. President Belfoure asked for a point of clarification, if the Policies and Procedures needed to be voted upon by the body before the RCIAA developed the

procedures? Patricia Rayford responded that the body does not have to vote for the RCIAA to develop Policies and Procedures. The Policies and Procedures will be voted upon at the Special Call Meeting.

New Club Handbook: presented by Committee Chair, Keith Glass. Past President Larry Anderson created a committee to develop a handbook for new clubs at the 2019 Alumni members. The New Club Handbook had been presented to all club presidents to provide to all of its club members well beyond the 30 days and thus the Alumni could vote of the New Club Handbook.
